Competitive Bid Request for Proposal Walkway Removal and Replacement

1.0 Introduction

Kennebec Valley Community College (KVCC) is soliciting proposals for the removal and replacement of two walkways for its Fairfield Campus located at 92 Western Avenue, Fairfield, Maine.

Duration of the contract will be based on a mutually agreed upon timeline and completion date.

A detailed explanation of the scope and specifications is contained in **Section 6.0, Scope of Services**. Preference will be given to the proposals conforming to the specifications provided; however, alternate recommendations may be considered. If a vendor chooses to make inquiries on the specifications provided, the rules set forth in **Section 8.0, Interpretation of Contract Documents**, apply. KVCC reserves the right to accept or reject any or all of the proposals received, in part or in whole.

2.0 Background

Kennebec Valley Community College (KVCC) is a comprehensive community college offering technical, career, and transfer education in addition to customized training for businesses and industries in Kennebec, Somerset, Waldo and Knox Counties. The College is located on two campuses in mid-Maine. Its 70-acre main campus in Fairfield, Maine, is reached by taking Exit 132 off Interstate 95. The new 600-acre Harold Alfond Campus is located seven miles north of the Fairfield campus on U.S. Route 201 in Hinckley, Maine.

6.0 Scope of Services

The Scope of Services set forth in this Request for Proposal (RFP) represents an outline of the services the College anticipates the successful proposer to perform and is presented for the primary purpose of allowing the College to compare proposals. The precise scope of services shall be negotiated between the College and the successful Proposer.

The successful bidder will supply all materials and labor for the removal and installation of two (2) walkways. Include with proposal any and all warranties for walkway construction and materials.

The Contractor shall:

- a. Be responsible for furnishing all supervision, labor, equipment, tools, supplies, facilities, and services required to perform the work including quality control, all required documentation at the conclusion of the project, warranting its work and performing all other work indicated in the Contract.
- b. Procure the materials required for the removal and replacement of the walkways
- c. Dispose of all excavated materials and comply with hauling and disposal regulations of authorities having jurisdiction
- d. Have the ability to work effectively with minimum supervision
- e. Make all preparations to secure and protect the surrounding areas
- f. Not store any removed items or materials on site without prior approval from KVCC officials

General Specifications for walkways:

- a. Remove existing walkway material
- b. Excavate area to a depth of 20”

- c. Base shall be 3/4" stone with a depth of 12" compacted
- d. 2" of high-density square edge Styrofoam 4' by 8' panels
- e. #4 rebar placed with a 16" grid pattern wired together with rebar support chairs using mutually agreed upon support chairs
- f. Concrete mix shall be 4000 PSI
- g. Concrete depth of 6"
- h. Edge concrete slab with edging tool
- i. Cut expansion joints in 5' increments
- j. Finish- broom finish using a medium bristled broom
- k. Finished concrete shall be slightly above the lawn elevation
- l. Repair lawn area around new walkway and any surrounding lawn areas that were disturbed during construction
- m. Seed and mulch disturbed lawn areas using hay

Additional Specifications for North End Walkway

- a. Dimensions of walkway (two sections)
 - 1. 9' by 69'
 - 2. 12' by 10'
 - 3. Total 741 square feet
- b. Drill and dowel with #4 in 16" increments the existing concrete slab and tie into new concrete

Additional Specifications for South End Walkway

- a. Dimensions of walkway
 - 1. 5' by 71'
 - 2. Total 355 square feet
- b. Add foam where new concrete meets existing brick paved patio

7.0 Contractor's Insurance

The Contractor shall maintain throughout the term of the agreement general liability insurance insuring against all claims of bodily injury or death, and property damage, arising out of work performed under this agreement. Such insurance shall provide coverage in an amount not less than \$1,000,000 per occurrence and shall list KVCC as an added insured Contractor shall also maintain worker's compensation insurance in amounts required by state law.

8.0 Interpretation of Contract Documents

No oral interpretation will be provided to any bidder as to the meaning of the specifications or other contract documents. Every request for such interpretation shall be made in writing at least three (3) or more days before the proposal due date and submitted to:

The College reserves the right to reject all proposals, to waive any informalities and technicalities, and to solicit and re-advertise for new proposals, or to abandon the project in its entirety. The College reserves the right to make the award to that proposer who, in the opinion of the College, will be in the best interest of and/or the most advantageous to the College.

5. add any entity as an additional insured to KVCC policies of insurance;
6. pay attorneys' fees or costs for any other entity;
7. promise confidentiality in a manner contrary to Maine's Freedom of Access Act;
8. permit an entity to change unilaterally any term or condition once the contract is signed; and
9. automatic renewals for term(s) greater than month-to-month.

By submitting a response to a Request for Proposal, bid or other like offer to do business with KVCC, YOUR ENTITY UNDERSTANDS AND AGREES THAT:

1. The above standard terms and conditions are thereby incorporated either expressly or by reference to this notice into any agreement entered into between KVCC and your entity, and that your entity will not propose or demand any contrary terms;

4. Your entity will identify at the time of submission which, if any, portion or your submitted materials are
